WHY D&A MATURITY?

Maturity is enabling organizations to produce benefits at scale



WHAT IS D&A MATURITY?



Maturity is the quality of interactions between the teams and their collaboration on standard practices

KPIs: Priorities alignment, elimination of redundancy, standard practices adoption, etc.









MATURITY MODELS* SUMMARY

Level 3 – Proactive / Systematic

- Clear, understood & adopted data & analytics strategy
- Consistent data & analytics standards implemented

Level 4 – Managed / Differentiating

- Strong business sponsorship, strategic alignment & accountabilities
- Performance measures and monitoring adopted & implemented

Level 5 – Effective / Transformational

- Business leaders drive data & analytics (including literacy)
- Strategic objectives driven by data
- Data skills value as competitive advantage
- Automation & accelerators in place

Level 1 – Aware / Basic

- Silos / reliance on individual talents
- Limited enterprise awareness, standards or monitoring

Level 2 – Reactive / Opportunistic

- Initial awareness
- Initial mobilization: no reliance solely on specific individuals




